Canadian PowerFloat REPAIR PROCEDURES

1. Ship to facility above.
2. Ship the PowerFloat in a suitable protective box or case. Remove all accessories and equipment that do not require inspection or repair from the package. **Each PowerFloat drill or attachment in the package will be evaluated and subject to an evaluation charge as listed below (***) unless otherwise specified.**

Remove all batteries from the shipment of cordless units. Lithium batteries are considered dangerous goods and require additional documentation for shipping due to potential hazards during transport.

For 14 Volt or 18 Volt drills/units, please contact the PowerFloat office at 1-877-969-2233 or info@powerfloat.net prior to shipping. Additional documentation will be required as one battery should be included in the package for evaluation of the unit.

If not shipping in the carrying case, make sure to use a rigid box with flaps intact, adequate cushioning material and strong tape designed for shipping. PowerFloat will not be responsible for damaged cases due to shipping.

3. Complete the **Repair Authorization Form**.
 - a. Email to: info@powerfloat.net **or** fax (403) 984-7702.
 - b. Include one copy in the package with your PowerFloat.
 - c. Retain one copy for your records.
4. You will be contacted with a quote prior to all repairs being completed. Customers are responsible for all shipping costs. Your PowerFloat will be returned to you upon receipt of payment.

***** There will be a \$200.00 evaluation charge on each PowerFloat drill or attachment evaluated but not approved for repair.**
